2573. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. Mrs. P. Bugeja and Cllr. Mrs. E. Thomas for this meeting.

2574. NOTIFICATION OF INTERESTS

Councillors were asked to state any interests in matters to be discussed at this meeting and reminded that changes to their Register of Interests must be made within 28 days.

2575. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meetings held on 1st December, 2015, having been circulated to members were agreed and signed by the Chairman as a true record.

2576. PUBLIC PARTICIPATION

Standing Orders were suspended to receive information.

Wyre Councillor's Report

Cllr. Murphy reported on the granted planning applications for the 300+ houses between Catterall and Claughton, although the MP had called the two applications the Secretary of State will not be supporting this. He added that Glenn Robinson, Lancashire County Council highways has stated that no other major applications will be considered following these two and the major application at Nateby.

Cllr. Murphy was asked about Wyre Council's Revenue Support Grant, yes the amount is known, but the ramifications have not been worked out to date. Shaping Your Neighbourhood should be along the same lines as last year.

Cllr. R. Hill was disappointed with the planning committee meeting which made the decision to allow the major housing applications when Lancashire County Council highways go money for road improvements, as NO improvements were explained to the public present.

County Councillor's Report

Cllr. Perkins reported on a complaint received concerning LCC highways decisions on the A6 and the officer in charge of those decisions. Lancashire County Council is experiencing numerous flooding problems, it was pointed out that building yet more houses will mean there is less space available for water!! Flooding problems on Cock Robin Lane were raised and, although Lancashire County Council are to get around to investigate, this is what Councillors were told 12 months ago and NO progress or work has been carried out. Cllr. Mrs. Perkins will raise the matter with officers.

An e-petition has been set up concerning Garstang Library on the Lancashire County Council web site and voting to save the library has opened. The Councillor asked the Parish Council to vote and send a letter of support. Jen Mein, Chief Executive, Lancashire County Council has stated there is no decision as to whether Garstang or Knott End Library will close. It was suggested that Garstang Town Council should list the library as a community asset.

There will be elections for the office of Police Commission on this May; Cllr. E. Taylor raised the absence of helicopter cover over Christmas as the machine was in for service and there is no alternative.

The meeting was resumed.

2577. FURTHER DRAINAGE PROBLEMS ON COCK ROBIN LANE

During the recent inclement weather it has been seen that parts of Cock Robin Lane are flooding and this standing water is encroaching into private drives. Some of the gullies are not draining away as quickly as others, the one at the junction with the A6 being highlighted. Cllr. Perkins reported that highways are to carry out gully cleaning, but there are other location priorities.

Resolved; That Cllr. Mrs. S. Perkins will contact the officer in charge to chase up previous complaints not acted upon in the past year.

2578. <u>LANCASHIRE COUNTY COUNCIL: CONSULTATION ON PROPOSED BUDGET</u> OPTIONS

Lancashire County Council is consulting on the cabinet's proposed budget options. Comments can only be made on-line and Councillors were asked to give their individual reply. This information and the withdrawal of local bus subsidies in April, 2016 were sent by e-mail. Councillors discussed the budget options and how each influences another. The Revenue Support Grant from Government is known, but 70% is already allocated to certain services and the rest is shrinking as the demand increases.

Resolved: The Parish Councillors commented on the withdrawal of bus subsidies leaving rural communities isolated, closure of Garstang library, nearest one Fulwood/Poulton, forcing more traffic onto the road system, more new houses (800+ in Garstang area making for more residents).
