3281. APOLOGIES FOR ABSENCE

No apologies were received for this meeting.

3283. MINUTES OF THE LAST MEETING

Resolved: Minutes of the Parish Council meeting and confidential meeting held on 1st December, 2020 having been circulated were signed as a correct record.

3284. PUBLIC PARTICIPATION

Standing Orders were adjourned to allow residents to speak.

Wyre Councillor Mrs. L. Webster

The Councillor reported Garstang swimming pool was being financially supported by Wyre Council, but is not opening due to the recent Covid lockdown.

Lancashire County Council Turner

The Parish Council received a report from County Highways; the site was visited and 'noted that the island had been clipped and overrun which confirms suspicions that its current position is problematic for certain vehicle types. Clearly the refuge does need repositioning in order to facilitate the unusual HGV movements that require access via Westfield Road. Regrettably though it isn't just a simple matter to pick up and relocate the refuge, there is actually a significant amount of civil engineering work required. Funding is not an issue, however the re-design needs to be undertaken in-house and unfortunately we have run into a delay in undertaking the necessary design works which will ultimately facilitate construction.' County is unsure of the impact of the current lockdown on construction capabilities.

Councillors were frustrated at this reply; Catterall Parish Council agreed to the weight limit on Cock Robin Lane and Joe Lane by removing objections to the current large planning applications and will be contacting Lancashire County Council. The misplacement of the traffic island means the weight limit is unenforceable by Police.

Councillor Turner reported that North West hospitals will fill due to the present rise in Covid 19 cases, but schools are to stay open where possible.

Standing Orders were resumed.

3285. GREEN FLAG AWARD - MANAGEMENT PLAN

Councillors accepted the Queen Elizabeth II Playing Field draft management plan subject to updating resulting from Wyre Council's walk round.

Resolved: To accept the presented document with updating following Wyre Council input.

3286. BUDGET/PRECEPT 2021 - 2022

Councillors considered the budget for the next financial year; in light of the impact of Covid on our residents and do not wish to impose a further financial burden on residents; some of whom will be in difficult situations.
