## 2814. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. Mrs. S. Bulman, Cllr. Mrs. P. Bugeja and Cllr. J. Finch for this meeting.

## 2815. NOTIFICATION OF INTERESTS

Councillors were asked to state any interests in matters to be discussed at this meeting and are reminded that changes to their Register of Interests must be made within 28 days.

# 2816. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meeting held on 5<sup>th</sup> September, 2017, having been circulated to members were agreed and signed by the Chairman as a true record.

## 2817. PUBLIC PARTICIPATION

Standing Orders were suspended to receive information.

**Michael Brown, Lancashire County Council** Well Being and Preventative Health Service were asking to visit to facilitate youth services for those living in Catterall. This will be an outreach service conducted from a mini bus located on the car park on alternate Wednesday evenings between 7 and 9pm. Catterall Village Hall Committee attended to hear the proposal.

Mr. Brown explained the youth club in Garstang was closed a number of years ago so the service now works from a converted mini bus parked on Booths two nights a week, but such a lot of attendees are from Catterall. The Village Hall Committee was concerned about congestion on the car park with events in the hall and will discuss the idea at their next meeting.

Councillors considered this would be advantageous for the Catterall young people and will discuss it next month in light of a decision from the Village Hall committee

Graham Anthony Associates with Mr. Collinson presented their proposed plans for newly purchased land in Catterall. Councillors discussed the maps and plans kindly circulated and agreed that this land has always been designated for industrial use. There was curiosity over the unusual office design and noted the proposed new route of the public footpath.

## Cllr. Shaun Turner

Lancashire County Council, Cllr. Turner and Cllr. Iddon, portfolio holder for highways were in Catterall on Saturday to inspect road problems. There was agreement on the state of Garstang Road south of Catterall Gates Lane and that many of the gullies in the village desperately need cleaning out to prevent flooding in heavy downpours. There is money left in the highway budget and this is to be channelled into maintenance. The re-structure in County Hall has made savings of £45 million through efficiency measures, but there is a financial hole at present. Interviews for the post of Chief Executive will be ongoing next week.

The four week closure of the A6 at the new Broughton By Pass was raised as was the site of the gallows at the A6 end of Joe Lane and its preservation now that work has begun on the residential development.

**Wyre Council**, He raised the very sad death of Cllr. Viv Taylor, Town Councillor, Wyre Councillor and Lancashire County Councillor. The leadership in Wyre has changed following the demise of Cllr. Gibson with Cllr. Vincent taking on the temporary role until 8<sup>th</sup> December.

The meeting was resumed.

## 2818. VACANCY IN THE OFFICE OF PARISH COUNCIL

The time has passed for the calling of an election; Councillors are asked to co-opt a member as soon as is practicable.

Resolved: There were no nominations at this meeting.

## 2819. CHANGE OF BANK

The Parish Council is to change the banking arrangements and open an account with Royal Bank of Scotland, following the closure of Lloyds in Garstang.

Resolved: Councillors will complete the related forms required by those who are to act as signatories on the account.

## 2820. ADDITIONAL SPID LOCATIONS

The Speed Indicator Detector (Smiley SID) was first used before the building of Summerdowns Estate and there have been reports of speeding from a number of residents in that area. Councillors considered additional locations on Catterall Gates Lane and Nightingale Way.

Resolved: To add further SpID locations on Catterall Gates Lane and Nightingale Way including these in the cyclical route.

### Catterall in Bloom

Cllr. K. O'Hanlon reported that being the end of the season the team is tidying up the flower beds and will start planning for next year. They are hoping to take over the grass verges at the junction of Cock Robin Lane with Calder Drive and fill them with plants.
