2956. APOLOGIES FOR ABSENCE

Resolved: The minutes of the Council meeting held on 5th September, 2018, having been circulated to members were agreed and signed by the Chairman as a true record.

Wyre Council

Wyre's Local Plan main modifications are out to consultation and comment at present. Cllr. Turner stated that the Government housing need calculation has changed and Wyre's supply number is reduced. At present there is an 11 year land supply therefore only the original land allocations in the Local Plan will be used and no further sites considered.

Lancashire County Council

Councillors were concerned at the change in advice from highways in a planning application for off street parking and is County highways prepared to maintain highway safety for other users.

The meeting was resumed.
