2825. APOLOGIES FOR ABSENCE

Anti-Social Behaviour – Problems with an estranged parent who has been trying to make unwanted contact with their adult child who wanted no contact was reported and a large group of lads were reported for drunken rowdy behaviour included falling in to the road and causing drivers to swerve to avoid hitting them.

2832. REPORTS FOR INFORMATION

Report on Queen Elizabeth II Field

Cllr. Finch reported on progress with the funding submission for £160,000 to provide a trim trail, wheeled sports area and older children's play area to be located on the Queen Elizabeth II Playing Field. The initial submission was online and now the appendices need printing out to send as a hard copy. The submission requires three quotes for each phase of the build and this has taken over four months to obtain in a way acceptable to the funding body. The Chairman expressed grateful thanks from the Parish Council to Cllr. J. Finch who has carried out this dedicated work since the original idea in 2015.

Report of the representative on Catterall Village Hall

At a recent meeting the state of the car park was discussed with the committee considering itself unable to raise any funds towards the cost and unrest about the refuse bin and who is using it.

Wyre Area Lancashire Association of Local Councils

Held last month, Rosie Green informed the Councillors that Wyre Council is carrying out a Youth Life in Wyre Survey. Wyre's Local Plan was presented by David Thow and Rea Psillidou. Wyre Council has been updating the Local Plan since 1999, but due to the number of Government policy changes, it will be submitted before Christmas. Public consultation offered three options; but due to Lancashire County Council's highway constrictions none of the options were possible.

Government demanding 9,000 houses by 2022 that is 479 per year - main constriction being the A585 trunk road and motorway junction – reduced to 8,220; 411 per year. The plan must offer both sustainable development and 5 year housing supply land. Flooding restrictions only apply to Pilling. Comments by 3rd November with a hearing in April to ensure the plan is sound i.e. it follows legislation based on the evidence and complies with policy. The Government publishing new methodology for housing needs for consultation. Junction 2 M55: provided this junction and D'Urton link is built there is an upper capacity of 850 houses on A6. At present not sufficient consent for these junctions to allow further development.

The Committee has invited the Clinical Commissioning Group to discuss how decisions are made on provision for the influx of residents caused by the amount of house building in Wyre.

Wyre River Trust

The Trust is looking at two areas of damage in Catterall and need to address both together. As there is too much water at present it will be Spring before work can begin.

Catterall in Bloom

Catterall in Bloom were presented with a Silver Gilt Medal Award last week in Southport. The **c**ommittee is to purchase a trough for the base of the Catterall boundary sign on Garstang Road and Netta and bloomers wish to thank the Parish Council for their support throughout the year.

Village Hall car Park Resurfacing Meeting
