2856. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. J. Finch, Cllr. K. O'Hanlon and Cllr. D. Sharples for this meeting.

2857. NOTIFICATION OF INTERESTS

Councillors were asked to state any interests in matters to be discussed at this meeting and are reminded that changes to their Register of Interests must be made within 28 days. Cllr. E. Taylor declared an interest as a neighbour for the application 18/00034.

2858. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meeting held on 2nd January, 2018, having been circulated to members were agreed and signed by the Chairman as a true record.

2859. PUBLIC PARTICIPATION

Standing Orders were suspended to receive information.

Including a Police Report

December Crime – Unknown offenders broke into shipping containers at a building site on Joe Lane; stole diesel and batteries and then ransacked the site.

Anti-Social Behaviour – A resident reported two males believed to be dealing drugs and acting antisocially, A Cock Robin Lane resident reported a number of uninvited males were trying to gain access to a party and another resident complained about the anti-social behaviour spilling out from the same party. A passer-by reported smelling cannabis being smoked from a white ford focus car on Catterall Playing Field.

The meeting was resumed.

2860. VACANCY IN THE OFFICE OF PARISH COUNCIL

Interviews to select a new member will take place next Tuesday 13th February. *Resolved: Interview questions were formulated.*

2861. POSSIBLE COMMEMORATIVE BENCH/S

Councillors were shown a possible design for a commemorative bench to mark the cessation of fire in WWI for consideration.

Resolved: The Councillors agreed to two benches, one at the Peace Garden and one at the Memorial Garden.

Resolved; Clerk to source the price of two benches.

The existing bench at the Memorial Garden will be relocated to Garstang Road as requested by Catterall in Bloom.

2862. LITTER BIN AT THE YOUTH SHELTER

The bin was completely vandalised and so removed. Councillors were asked if they wish it to be replaced; bearing in mind that once the CCTV is in place and the Robin bin is in the play area Wyre Council will gift the Parish Council the Jubilee litter bin situated at the start of the public right of way off the playing field.

Resolved: Not to replace the Youth Shelter bin at this time.

2863. <u>HIRE OF THE QUEEN ELIZABETH II PLAYING FIELD</u>

Myerscough Junior football manager has inspected the pitch and would like to hire the field for half a season between March and July. It was raised that the field would not be available for the Gala weekend or the circus visit in July. Councillors considered and agreed with the request.

Resolved: To allow Myerscough Juniors to play on the football pitch on the Queen Elizabeth II Playing Field.

2864. OFFER OF LIVING CHRISTMAS TREE

The Parish Council has been offered a live conifer to plant as a Christmas Tree discussions as to the best place ensued. The entrance to the Queen Elizabeth II Playing Field near to the gate was settled on; a power supply will need locating and a feeder pillar installed.

Wyre River Trust

Cllr. E. Taylor reported that Wyre River Trust will be using the Christmas Trees with Willow logs to build up the embankment at the side of the playing field and hope to be finished by the end of the month.

Defibrillator Fund

A site meeting was held at the Memorial Garden with Peter Bond from the Red Cross and a suitable location found, although a wall will be needed to mound the defibrillator. The Chairman and staff at Churchtown Garage appeared in the Courier after an article was sent. The cost of the defibrillator and case has now been reached suitable models will be sought.

Catterall Gala

Cllr. S. Kirkman reported on a loss last year and the committee thanked the Parish Council for their donation. This year's Gala will be held on 4th June, 2018.
