## 2508. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. J. Finch, Cllr. D. Harvey, Cllr. J. Houghton, Cllr. D. Sharples and Cllr. E. Thomas.

## 2509. NOTIFICATION OF INTERESTS

Councillors were asked to state any interests in matters to be discussed and reminded that changes to their Register of Interests must be made within 28 days.

## 2510. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meetings held on 2<sup>nd</sup> June, 2015, having been circulated to members were agreed and signed by the Chairman as a true record.

## 2511. PUBLIC PARTICIPATION

Standing Orders were suspended to receive information.

## Wyre Councillor's Report

Cllr. P. Murphy reported on the recent planning application for housing from Cock Robin Lane to the Toll Bar, which was before Wyre's planning committee last week. As the applicant had submitted an appeal the committee could only resolve, and not decide, but the resolution was to refuse the development on highway capacity grounds. Due to the present capability of the highways around Garstang all large planning applications are on hold. This is compounded as Lancashire County Council is not prepared to finance any major road infrastructure plans inn Wyre.

He continued with the consultation on Wyre's Local Plan proposition with the recent public presentation and stressed that the land identified in the plan is only a possibility. The Chairman raised the public perception of 'affordable housing' as it is NOT houses that are affordable, but rather council housing for rent or shared ownership. There was a call for smaller houses/starter homes.

Cllr. Murphy is portfolio holder for Shaping Your Neighbourhood in Rural East and, as the new holder, he will be calling a meeting of Parish Councils to discuss its future and how it is to work.

## **Including Police Report**

There is a general reduction in all incidents and crimes and any increases do not include Catterall. Sergeant Freaney apologies for the lack of content in the crime and incident figures, but due to a decrease in staff and increased work load everything is stretched. A volunteer is co-ordinating the figures at present and hopefully in future a second volunteer will compile the summaries.

The meeting was resumed.

## 2512. WYRE'S LOCAL PLAN

Information concerning the consultation on Wyre's Local Plan was circulating and the Planning ambassador has attended an initial meeting at Wyre. The Parish Council has heard that Wyre Council will be visiting each Parish Council, but ahead of that was a suggestion for local parishes to discuss together the implications of the local plan. Resolved: A cluster Local Plan meeting will be held on Thursday 16<sup>th</sup> July, 6pm, at Shared Approach, with local Parish Councils.

Resolved: The planning training in Wyre will be attended by the Chairman and Clerk.

## 2513. PARISH LENGTHSMAN TRAINING

Councillors considered sending the Parish Lengthsman on a First Aid Course, as his certificate has run out. Adult education has no courses, but Barton Grange is running a certified course in practical first aid skills; this would give confidence to assist in emergency situations with a cost of £29.50.

Resolved: The Parish Lengthsman will attend a First Aid course on 10<sup>th</sup> September at Barton Grange.

#### 2514. ALLOTMENTS

Following information that the Potato Field is to be sold, Councillors undertook a site meeting to determine if the area between the playing field and the open space off Keepers Wood Way would be suitable for allotments. The report of the meeting was distributed which considered that the Parish Council could not undertake to provide allotments due to possible land costs, plus the preparation and on-going costs required for provision of allotments. The Councillors indicated fencing the boundary between the Potato Field and the Queen Elizabeth II Playing Field due to the imminent sale of the field. There was a suggestion to employ a contractor or perhaps do the job in house.

Resolved: That the mowed grass is taken back to the mill race to define the Queen Elizabeth II Playing Field and a hawthorn hedge is planted in Autumn.

#### 2515. BOUNDARY COMMISSION

The Boundary Commission is to commence an electoral review of Lancashire County Council; does the Parish Council wish to add any comments?

Resolved: To wait until the commission publishes their proposals before commenting.

#### 2516. SPEEDING ON GARSTANG ROAD

Cllr. E. Taylor asked that the Police and Lancashire County Council are contacted to establish what can be done to slow the speed on Garstang Road? Dialog between Inspector Jackson, the Parish Council and Police enquiries have resulted in Garstang Road being risk assessed for the use of the 'speed van' and the outcome is imminent.

The Councillor has conducted his own speed count and this averaged out at 42MPH on this 30MPH road. The Police speed/traffic officer is to visit Cllr. E. Taylor to assess the situation.

Resolved: To try and arrange for the use of a clever SpID to support speeding figures.

## 2518. ST. HELEN'S CHURCH NOTICE BOARD

Mrs. S. Tearle, a churchwarden at St. Helen's, is appealing to Catterall Parish Council to consider the possibility of reinstating the Church's notice board in the new Stone Cross Garden? It was originally located at the shop but was removed during the extension work; it could be reinstated at the shop but would not be easily seen. Councillors considered the request, but felt another notice board could not be incorporated into the design' which is now completed, as it would crowd the garden. It was suggested that the Village Hall should be approached.

Resolved: Whilst the Parish Council is unable to incorporate the notice board on Stone Cross Garden: Catterall Village Hall could be approached.
