3389. QUEEN'S PLATINUM JUBILEE

The Queens Platinum Jubilee is to be held **2nd - 5th June 2022**. Is Catterall Parish Council to celebrate this occasion?

Jubilee Beacons - The whole celebrations start with the lighting of beacons on the evening of the 2nd. The Lancashire Lieutenancy is the "Beacons Champion". There is an official website - <u>https://www.queensjubileebeacons.com/</u> - that gives a guide to all matters involved including options, administration, insurance etc. Most importantly it gives you the opportunity to register your interest.

Report of the Wyre Area Lancashire Association of Local Councils

Attended by Mark Billington, Wyre Council the meeting discussed the growing number of planning enforcements in the system and lack of action. Wyre Council has two enforcement officers to deal with over 170 reports at the present time. Mr. Billington made note of the cases offered by the parishes but said he could not comment on individual cases.

DEFRA is to consult on the future of waste and manufacturer's packaging and a deposit scheme. Wyre Council staff have been deployed during Covid. Wyre Council has received £50million in Covid grants for discretionary use to organisations by March 2022.

Cllr. J. Makenzie reported during the school holidays parties have been booked and they may be oversubscribed in September. The cost of the commercial bin was raised.

3396. QUESTIONS FOR COUNCILLORS

Raw sewage on public footpath, near Collinson's

The Chairman has spoken to Wane Home, Wyre Council pollution team visited the site and found nothing, and United Utilities rang and sent their rep on site.

Jon Ganley, Customer Care, Wainhomes, states United Utilities contacted them, Drain Doctor does not visit every other day and there is no residue. Drain Doctor removed a blockage initially, but this has not happened since. He has checked the utility access holes and there is no problem.

M6 between junctions 33 and 32 – essential bridge repair work update

The repairs are almost complete, now scheduled to finish on 21 August 2021. Remove the temporary bridge supports and traffic management. Overnight closures of the M6 southbound carriageway between junctions 33 and 32 are planned for 9 August 2021, 19 and 20 August 2021, between the hours of 9pm and 6am slip road closures will also be required, and localised signed diversion routes will be in place.
