2536. APOLOGIES FOR ABSENCE

Apologies were received for this meeting from Cllr. I. Brayshaw, Chairman, S. Blanthorn-Hazell, Vice Chairman, Cllr. J. Finch, Cllr. D. Sharples and Cllr. Mrs. E. Thomas.

2537. NOTIFICATION OF INTERESTS

Councillors were asked to state any interests in matters to be discussed and reminded that changes to their Register of Interests must be made within 28 days.

2538. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meetings held on 4th August, 2015, having been circulated to members were agreed and signed by the Chairman as a true record.

2539. PUBLIC PARTICIPATION

Standing Orders were suspended to receive information.

Speeding on Garstang Road

A resident was vehemently against the Police speed van being located at the Village Hall to deter speeding vehicles on Garstang Road, although there was also a resident who supported slowing speeding vehicles through Catterall. There was a suggestion that purchasing another SpID to be used in the village would be more effective on speeding drivers and cheaper than creating a hard standing for the Police speed van. There was also concern that sight lines would be obscured by the hard standing at the entrance to the Village Hall. The County Councillor is to pursue the speeding statistics for Garstang Road.

A resident questioned the Parish Council; who were considering the purchase of two defibrillators to be located in Catterall; however no decision has been made to date and the resident did eventually agree with the need in Catterall. There was a report of cars spinning around the Village Hall car park in the early hours of the morning and a request that each night the gates to the Village Hall are closed, this resident will continue to report any incidents to the Police.

Lancashire County Councillor's Report

County Cllr. Mrs. S. Perkins had been lobbying Lancashire County Council concerning the trenching on Garstang Road caused by utility cuttings, they were inspected recently and reinstatement work is scheduled. The Boundary Commission is to announce changes to Lancashire County Councillors divisions and as Garstang is 17% above average this will need reducing. But the suggestion for Garstang appears to be illogical and a review has been requested. The County Councillor also runs a Memory Café each month on first Wednesday morning and third Monday afternoons in Garstang Library for those with Dementia, their carers and friends.

The Claughton Recycling Centre is to open on 18th September and will accept anything that can be recycled. No inert waste can be accepted at Claughton as it costs so much to dispose of, but Longridge tip can be used for this. Inert waste comprises building materials, doors, bathrooms etc.

The meeting was resumed.

2540. REQUEST FOR PERMISSION FOR CHURCH NOTICE BOARD

St. Helen's Parochial Church Council is seeking permission from the Parish Council to place their notice board at the junction of Garstang Road and Cock Robin Lane. Mr. Arthur Cartain gave a presentation concerning the design and location in front of the CCTV pole and there were no objections.
