MINUTES OF THE PARISH COUNCIL MEETING

Apologies were received from Cllr. Mrs. P. Bugeja, Cllr. Miss J. Finch and Cllr. Mrs. E. Thomas.

2346. DECLARATION OF INTERESTS

Councillors were asked to state their pecuniary and non pecuniary interests in matters to be discussed at this meeting.

2347. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meetings held on 6th May, 2014, having been circulated to members were agreed and signed by the Chairman as a true record.

2348. PUBLIC PARTICIPATION

Standing Orders were suspended to allow residents to speak.

Application to stop up Catterall Lane

A number of residents were most concerned about an application to stop up the highway at the end of Catterall Lane; this also involves the relocation of a public footpath across land rather than accessing the metalled road. The residents told of signs indicating shooting over the public footpath and users being intimidated by positioning of empty shot gun cartridges at the entrance to the public footpath. They were also concerned that this part of Catterall Lane is used to park vehicles when accessing the public footpath and there is no suitable alternative.

The meeting was resumed.

Councillors voted to bring the following item forward for discussion.

2349. PROPOSED STOPPING UP OF CATTERALL LANE

Councillors considered the consultation, it was noted that only the district and Parish Council has the power to object and this then calls for a magistrate to investigate the matter. The Councillors, understanding the residents concerns, will object and Lancashire



County Council has informed the Parish Council that residents' letters/emails will be presented to the magistrate for consideration.

Resolved: That Catterall Parish Council objects to the stopping up of Catterall Lane as described by Lancashire County Council.

2350. MEMORIAL GATE

Councillors decided on a design and colour scheme for the plaque. Pictures of the gate in its 'raw state', before galvanisation, were shown. The gate will be hung when completed and hopefully blessed by Rev. Andrew Wilkinson, as Deacon to the Armed Forces Resolved: To give the final design to Fleetwood High School, an oval plaque in black with red writing.

2351. CLAUGHTON HOUSEHOLD RECYCLING CENTRE

Lancashire County Council would like to know if the Council has any views concerning charging to use the recycling centre. Some authorities charge for particular waste types that are delivered (eg green garden waste, 'residual' waste, etc), whilst other authorities charge each vehicle that enters the recycling centre a small fee.

Resolved: The Councillors considered that there should be no charge for individuals but charges made for commercial/trade waste by businesses.

2352. CATTERALL CRIER DONATION

The Gala Committee has delivered the Spring edition of our Catterall Crier and the Parish Council usually give a donation. Councillors consider a donation, but are very concerned at the state of the field following the fairground vehicles leaving the site. There are deep ruts in the football pitch and some of the vehicles have damaged the field and the footpath. Dave Kippax has been approached in an effort to minimise the ruts. The repair bill will be presented to Catterall Gala Committee.

Resolved: Catterall Gala will be sent a donation of £50 for the delivery of Catterall Crier.

2353. NOTICE OF PROPOSAL LANCASHIRE COUNTY COUNCIL ROAD TRAFFIC REGULATION ACT 1984 (VARIOUS ROADS, EVERY DISTRICT, LANCASHIRE) (AMENDMENT OF 2009 CONSOLIDATION ORDERS) ORDER 201*

Lancashire County Council is looking to change the legislation for parking on restricted parking bays to allow parking wardens to issue fines as opposed to the Police. *Resolved: The Parish Council has no objections to the changes.*

2354. REQUEST FOR DONATION

A young Catterall resident is to teach in South Africa and must raise £1,000 to cover costs. Councillors considered this request.

Resolved: To grant £100 and request a short presentation once home.

2355. LOCAL GOVERNMENT PENSION SCHEME - EMPLOYER DISCRETIONS

The Finance Committee recommends that the LGPS, tailored to Catterall Parish Council is accepted by the full council.

Resolved: Councillors accepted the Employer Discretions for Catterall with the Local Government Pension Scheme.

2356. CCTV RELOCATION

The pole has been moved and is waiting for an electrical connection. Wyre Council will be cutting back the trees to give line of sight to the Village Hall. The Councillors will need to select their preferred system.

Resolved: To chose the CCTV system by next meeting.
