Apologies were received from Cllr. S. Blanthorn-Hazell and Cllr. Miss J. Finch and the reasons accepted.

2300. DECLARATION OF INTERESTS

Councillors were asked to state their pecuniary and non pecuniary interests in matters to be discussed at this meeting.

2301. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meetings held on 4th February, 2014, having been circulated to members were agreed and signed by the Chairman as a true record.

2302. PUBLIC PARTICIPATION

Standing Orders were suspended to allow residents to speak.

Police Report

There was one crime in the past month when a car tyre was deliberately punctured on driveway on Boyes Avenue; the car had been parked up for two weeks, compared to none last year. Anti-social behaviour showed no patterns with only one incident relating to a neighbour dispute on Boyes Avenue.

Pickerings Planning Application

A resident asked if the Parish Council were going to the planning committee tomorrow to speak about the Pickerings application. The chairman and clerk will be attending and a statement was read out.

WWI Memorial

A resident introduced the Councillors to a scheme being run to mark the anniversary of the outbreak of WWI by purchasing poppy seeds. The seeds will be bought by those who lost someone in the war and planted on public ground. He suggested the grass verge on Garstang Road. The Councillors fully supported this idea and also suggested the verge on the A6 as a suitable site.

The meeting was resumed.



2303. ROADSIDE FENCE TO THE QUEEN ELIZABETH II PLAYING FIELD

Resolved: The Parish Lengthsman asked about the continuing maintenance of the roadside fence. He needed to know if it was still required and if so he would replace rotten/damaged rails and uprights as needed. It was not that major work was required to the fence. Therefore as Councillors resolved to keep the fence; maintenance will be continued.

2304. MEMORIAL GATE 1914 - 2014

Councillors discussed the tenders received, were concerned at the differences and requested further information to compare the quotes.

Resolved: To ask for further information and a full specification to the metal being used, construction etc.

It was noted that funding has proved difficult as funders are only looking at schemes costing over £3,000, however, there may be chance with the Duchy of Lancaster.

2305. SUMMER FOOTBALL LEAGUE

Brockholes Arms FC is requesting the use of Queen Elizabeth II Playing Field, Catterall for the first and second teams in the 2014 Catforth and District Summer League Season. The season runs from May to August, with games played on Monday and Wednesday evenings. Councillors considered this request and reviewed the costs of each game. Resolved: The Brockholes Arms are given permission to play on the new pitch, the cost per game will be £28 paid in advance.

2306. REQUEST FOR DONATION

At last month's meeting St. Helens Parochial Church Council were asked to provide a break down of costs for the upkeep of the graveyard and this has been supplied.

Councillors reconsider this request in the light of the information supplied.
