Apologies were received from Cllr. I. Brayshaw and Cllr. E. Taylor.

#### 2386. DECLARATION OF INTERESTS

Councillors were asked to state their pecuniary and non pecuniary interests in matters to be discussed at this meeting.

#### 2387. MINUTES OF THE LAST MEETING

Resolved: The minutes of the Council meetings held on 5<sup>th</sup> August, 2014, having been circulated to members were agreed and signed by the Chairman as a true record.

#### 2388. PUBLIC PARTICIPATION

Standing Orders were suspended to allow residents to speak.

#### **Police Report**

Crimes reported last month include unknown offender(s) setting fire to a waste bin on Catterall Playing Field, 5 unknown offenders on Garstang Road damaging the front wing of a parked vehicle with tarmac, a domestic incident on Old Lancaster Road and an argument on Whitewell Close, which lead to punches being thrown.

Anti-social behaviour incidents included comments on Facebook and personal messages at an address on Thornbank Drive, youths suspected of throwing objects at passing cars from Catterall Playing Fields, an abandoned car on Garstang Bypass Road, a dispute when a delivery driver was insulted and sworn at, when making a delivery on Garstang Bypass Road and a neighbour dispute on Thornbank Drive.



#### **County Councillor**

County Councillor Mrs. Sandra Perkins complimented the Parish Council on the Memorial Gate and plaque, dedicated at the weekend and then reported on a meeting she had attended in Wyre to discuss the Wyre Area Lancashire Association of Local Councils planning applications letter sent to Cllr. Peter Gibson, leader of Wyre Council and Garry Payne, the Chief Executive. Wyre Council stated there is no legal reason why all these large planning applications shouldn't go ahead. The Kepple Lane plan received a deferment, but would probably be granted tomorrow at committee as the developer is to pay towards education and highways.

Lancashire County Council has lost out on a bid for grants towards community transport. The County Councillor will be holding a memory café in Garstang Library on the first Wednesday of the month. She was asked about the tip opening and it is hoped it could be before Christmas.

The meeting was resumed.

#### 2389. LUNE VALLEY RURAL HOUSING ASSOCIATION

The association invites Catterall Parish Council to become a shareholder to help raise the profile of the association and guide the strategic aims of providing more affordable homes for local people. Whilst the Parish Council would wish to have an input into homes in the Parish it is felt more advisable not to become a shareholder in one particular social landlord at this time.

Resolved: Not to become a shareholder at this time.

### 2390. PARKING PROBLEMS ON CALDER DRIVE

Cllr. J. Houghton has been approached by residents of Calder Drive as to the narrow road and lack of parking spaces, especially from numbers 23 to 27. There is a suggestion that the grass could be removed to accommodate vehicles and Councillors considered this in the light of a similar scheme carried out in Garstang.

The meeting was suspended to allow residents to speak

The lack of parking spaces is causing animosity between families, the grassed area is too small for play and Wyre Council's cutting standard has left the area two foot deep in grass at the present time as it is 8 weeks since the last cut.

The meeting was resumed.

Councillors were sympathetic to the request, but would need to establish the landowner initially to proceed. The matter will also be raised with Lancashire County Council highways through the County Councillor.

Resolved: To establish the landowner of the grass area on Calder Drive.
